## 1) How to create an account?


### 如何注册账户?

a) Enter <a href="https://hk.one-line.com/">https://hk.one-line.com/</a> to sign up.



b) Read and agree to the Indemnity Agreement and press the "Next" button.

c) Then enter information and press "Next" button and "Confirm" to save data. 填写栏目所示信息,按"NEXT"+"Confirm"保存








d) All registration information will be shown in the review page of Approval. Please press "OK". System will confirm User ID activation via email notification after verification process done by Administrator.

## 2) How to submit and edit VGM? 如何申报/重报 VGM?

a) Login to ONE's e-Commerce applications and go to part of "VGM Input".

登陆 ONE 的 e-Commerce applications 版面,选择" VGM input" 模块


b) "VGM"=Method 1 and "Cargo Weight"=Method 2

选择 "VGM"等同方法一;选择"Cargo Weight"等同方法二

i) For VGM submission by container no. Enter container no. and search. Update details of **Weight Type/ Unit/ Weight** and then save the data.

选择以"Container No"柜号搜索,并输入柜号申报 VGM。选择并填写 Weight Type/Unit/Weight 的相关信息并保存。



ii) For VGM submission by Booking no. Enter booking no. and search. Update details of Weight Type/ Unit/ Weight and then save the data.

iii) For Mass Upload VGM, pleases press "Download" button to get the excel file. Please input the Container No./ Booking No./ Weight Type/ Weight/ Unit/ Signatory/ Reference ID. Then click the "Upload" button to save data.




# 3) How to check the container Tare Weight?

请在 Container No 旁输入所查询的柜号,并按"Search",随之柜皮重会显示出来。






# 4) How to search VGM Info.? 如何搜索 VGM 信息?

a) Search the VGM Info by Container No.


进入以下 VGM Info Search 界面,选择 Container No 并输入柜号
