Phase 1 (effective on 16 December 2019, Monday)

AM CUT-OFF (10:30)

- Order received at Counter **before** AM cut-off time will be ready by 12:30;
- Order received at Counter after AM cut-off time will be ready after 15:00 on the same day.

PM CUT-OFF (15:30)

- Order received at Counter **before** PM cut-off time will be ready on the same day;
- Order received at Counter <u>after</u> PM cut-off time will be ready by 12:30 on the next working day.

Phase 2 (effective on 13 January 2020, Monday)

AM CUT-OFF (10:00)

- Order received at Counter **before** AM cut-off time will be ready by 12:30;
- Order received at Counter after AM cut-off time will be ready after 15:00 on the same day.

PM CUT-OFF (15:00)

- Order received at Counter **before** PM cut off time will be ready on the same day;
- Order received at Counter <u>after</u> PM cut off time will be ready by 12:30 on the next working day.

Phase 3 (effective on 10 February 2020, Monday)

Paper D/O will not be issued. Special arrangement will be applied to suit individual circumstances, where necessary.
